Various education reform packages have been applied to transition societies during the past 20 years, with many having a strong impact on classrooms, textbooks, and other discreet aspects of teaching and learning. To date however, reform efforts have virtually ignored school leadership, which has weakened implementation of policy reforms at the school and national level. Many transition societies are emerging from school governance structures that were largely authoritarian and centralized. It is tempting to import "proven" leadership approaches and policies from the West, where the field of educational leadership has been home to numerous innovations and democratic approaches over the past 50 years. However, consideration must be given to the appropriateness of such Anglo-American leadership approaches for transition country contexts. In this seminar we search for bridges between the Western models and the local interests in such transition countries.

NEPC Summer School shall frame educational leadership through its application to examples of "hot topics" facing school principals/leaders in schools today: ***Finding the visionary***: shift from "management" to "leadership" , ***Seeing a better future***: leaders as change agents , ***Maximizing local knowledge***: leading learning communities, ***Democratizing education***: ethics, norms, and public relations, and ***Effective decision-making***: using data for continuous improvement.

Themes:

- **Leaders as change agents** - theoretical background of leadership/the theme and it's practical application in education in transition contexts, emphasizing the aspect of personal leadership
- **New policy for a new era**- policy frameworks, standards, accreditation and training models from various countries (Canada, Georgia, Russia, Slovenia, South Africa, Switzerland, UK, USA)
- **Research in unprecedented leadership trends – case studies** :
 - a. image of school principals through large-scale survey - Balkan countries;
 - b. "profile" of school principal and his/her perceptions of leadership through qualitative study – Azerbaijan.

Pedagogical Strategy

Faculty will model distributed leadership principles in pedagogical strategies of the workshop by utilizing informal groups and discussions which allow for emergent leadership among group members. Short lectures and multimedia will be used to explain central concepts, and non-formal spaces (e.g., websites) will be used to document participants' experiences and international leadership trends revealed during the courses. Because self-reflection is a central element of effective leadership, participants will complete several self-assessment inventories during the seminar and will be required to reflect on the results.

Who should apply?

- School principals / leaders
- Policy makers and implementers at national and regional level
- Graduate students in education policy and educational leadership/management studies

Pre-seminar Activities

Several brief readings will be assigned to participants two months prior to the start of summer school. Selected participants would be asked to bring any papers they might find related to educational leadership in their country and will be asked to complete a brief fictional case study of educational leadership in their country (guidance will be provided in advance). The case studies submitted will be integrated into the summer school curriculum content.

Evaluation and Assessment

Participants will be asked to complete two short, practical written assignments by the conclusion of the course. Specific guidelines will be provided for these assignments during the seminar. Faculty will send feedback to participants within two weeks after the summer school's conclusion.

Expected Outcomes

After participating in the summer school, participants will be able to:

- Demonstrate reflective practice of leadership (social-psychological)
- Distinguish between management and leadership (behavioral)
- Demonstrate policy skills educational leadership by applying new concepts of educational leadership to their own context (political)
- Show basic research skills in the area of policy (cultural)
